▶ **APPLICANT'S REASON FOR CHANGE:** To comply with the Knox County Uniform Street Naming and Addressing Ordinance, MPC administrative rules and assist emergency services in locating residents whose property is accessed by this easement. This easement is over 2,000 ft. long and serves 10 parcels.

STAFF RECOMMENDATION:

▶ **APPROVE** the name "Goose Landing Way"

This name is needed to assist emergency service providers, as well as the general public, in locating residences served by this private access.

COMMENTS:

Naming of this private drive is required by the Knox County Uniform Street Naming and Addressing Ordinance.

If approved, this item will be forwarded to Knox County Commission for action on 4/24/2006. If denied, MPC's action is final, unless the action to deny is appealed to Knox County Commission. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 30 days to appeal an MPC decision in the County.
