▶ **APPLICANT'S REASON FOR CHANGE:** New construction with Smart Fix 40 project that extends the current Hall of Fame Drive. Renames the current Hall of Fame Drive to S. Hall of Fame Drive from Jackson Ave., south to Howard Baker Jr. Ave. Names unnamed portion and N. Fifth Ave. to N. Hall of Fame Dr. from Jackson Ave. to Broadway intersection.

STAFF RECOMMENDATION:

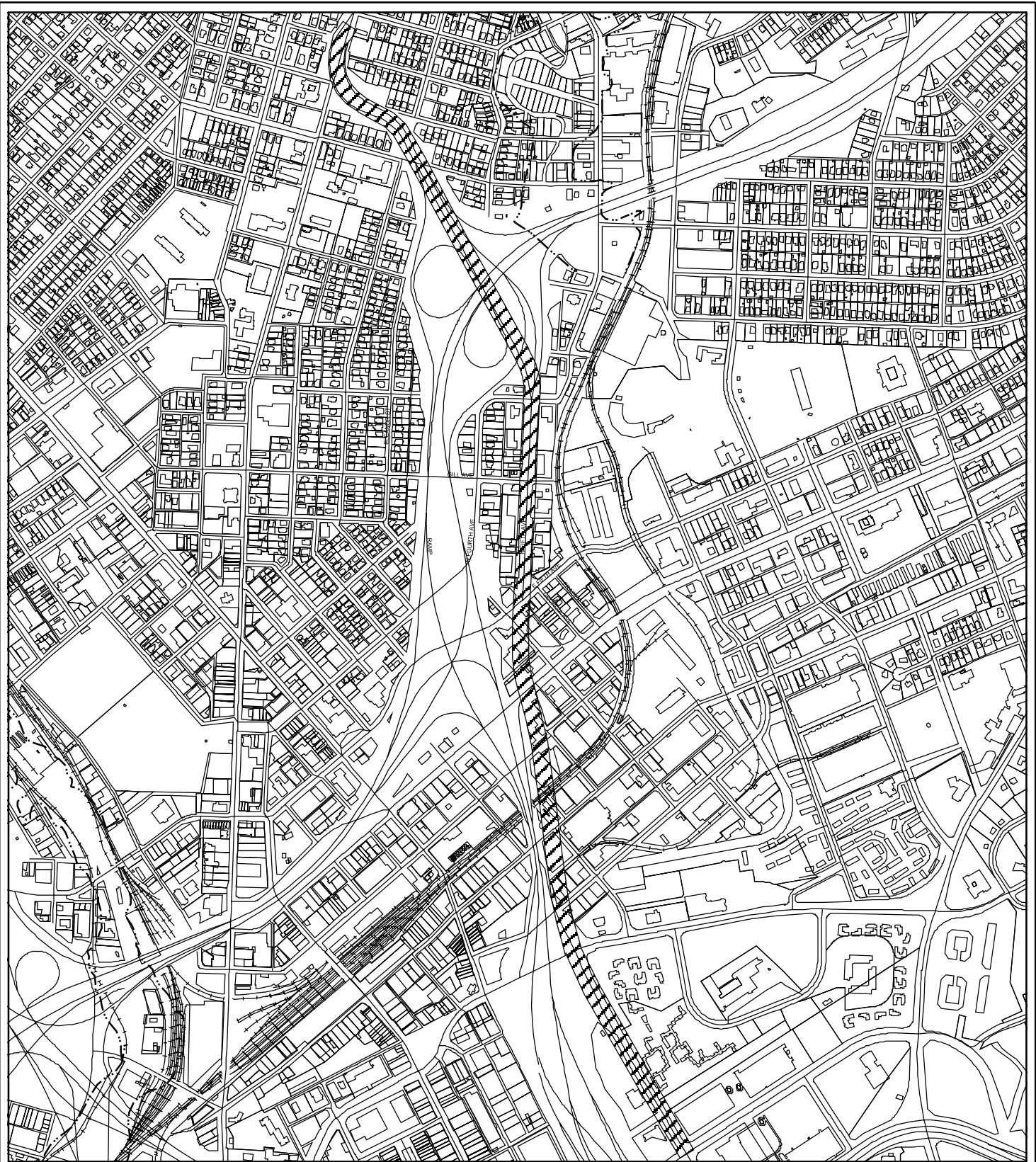
▶ **APPROVE** the name "Hall of Fame Drive"

This will provide the same name for a continuous street section resulting from the Smart Fix 40 street construction project.

COMMENTS:

There are few property address changes that result from this name change.

If approved, this item will be forwarded to Knoxville City Council for action on 11/7/2006 and 11/21/2006. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.
