My name is Christina Horn and I reside at 5401 Yosemite Trail. I have lived in this neighborhood for one year and absolutely love it. People here are friendly and always say hello when they see me walking my two German Shepherds. I am a professional pianist with a Master's degree in piano pedagogy and teach piano lessons as my full time occupation. I have been doing so for 10 years. I am writing this letter to you, my neighbor, to inform you of what I do in my home so that you can feel like comfortable with my home occupation.

I teach 22 students a week, one at a time, for 30 minutes a piece. My hours of operation are Monday through Thursday from 3pm until 8pm. My students park in my driveway and come in through the back door of my basement. For the past year, my roommate has also taught one student at a time during the same hours. As of October 1, she will be moving. I will be the sole tenant and teacher living at 5401 Yosemite trail.

I write this letter also in apology for creating any inconvenience to you, my neighbor. This summer I had a group of 10 students come to my home for 8 days total: We played games in the yard but spent most of the morning in my basement studio. I now realize that the law only allows for one student at a time, and have ceased the program. Again, my sincerest apology for any disturbance this may have caused you, it will not happen again.

It is my desire to live within the laws of our community and to be a good neighbor. I believe that my home occupation is an honorable one and I strive to act in a professional manner. Please feel free at anytime to come by and speak with me or to call of you ever have any concerns.

I am writing to ask you to allow Christian Horne to continue providing piano lessons in her home. Private music instruction is a very valuable thing, and quality teachers are hard to find. When I found Christina as a teacher for my children, I knew how lucky I was She was able to offer my children caring, high-quality, personalized instruction, and, because she was able to offer the lessons in her home (like generations of music teachers before her!), the price of the lessons was within my reach.

We have been with Christina for 3 years now. From all my observations, she is a very good neighbor: her home is well-maintained and fits well into the residential area (there are NO signs or architectural features that announce it as a place of business.) She has a large driveway and has asked us to be considerate of her neighbors by always parking in the driveway. The music room, in the basement, has no windows facing other houses, so there is no "noise" to disturb the neighbors. The parents who bring their children for lessons there treat the neighborhood with respect, driving slowly and quietly in and out. In fact, in the past, I know that some of Christina's students have lived right in her neighborhood.

The tradition of private music lessons in the home is a long-standing one of great value. I myself took lessons at the home of my teacher, and many children all over Knoxville are doing so right now. The tradition of teaching in the home puts these lessons within reach of children who otherwise would not be able to afford them. Dear Ms. Schlitz,

I am writing to you in support of Ms. Christina Horn, my daughter's piano instructor, who lives in the Timbercrest neighborhood at 5401 Yosemite Trail (Knoxville, 37909). I was very surprised to hear that Ms. Horn is having problems with her neighbors in the area. Ms. Horn has been very careful to request (verbally and in writing) that parents of her students park in the driveway if they plan to stay for the lesson. I can honestly say that I have never seen more than ONE car in her driveway (let alone in front of her house) except for the brief transition time when one student is finishing a lesson and another is beginning. Believe me, many of my neighbors in West Hill often have more cars outside their homes for a variety of different reasons.

My two daughters have studied with a total of four different teachers over the past 8 years, all of whom taught in their homes and one of whom lived in the exact same neighborhood as Ms. Hom. NONE of them ever had any problems with their neighbors. As someone who lives and works nearby (I serve a church at the corner of Weisgarber and Lonas Roads), I too care about quality of life in the neighborhood and can see no reason why Ms. Horn's piano lessons would be viewed as either a threat or an inconvenience to her neighbors. In general, instrumental music teachers do not make a lot of money, yet contribute a great deal to the wider community by sharing the joy of music with children and teaching them a great form of personal discipline. It would be a shame if we begin to make it difficult for them, of all people, to live and teach in our neighborhoods.
