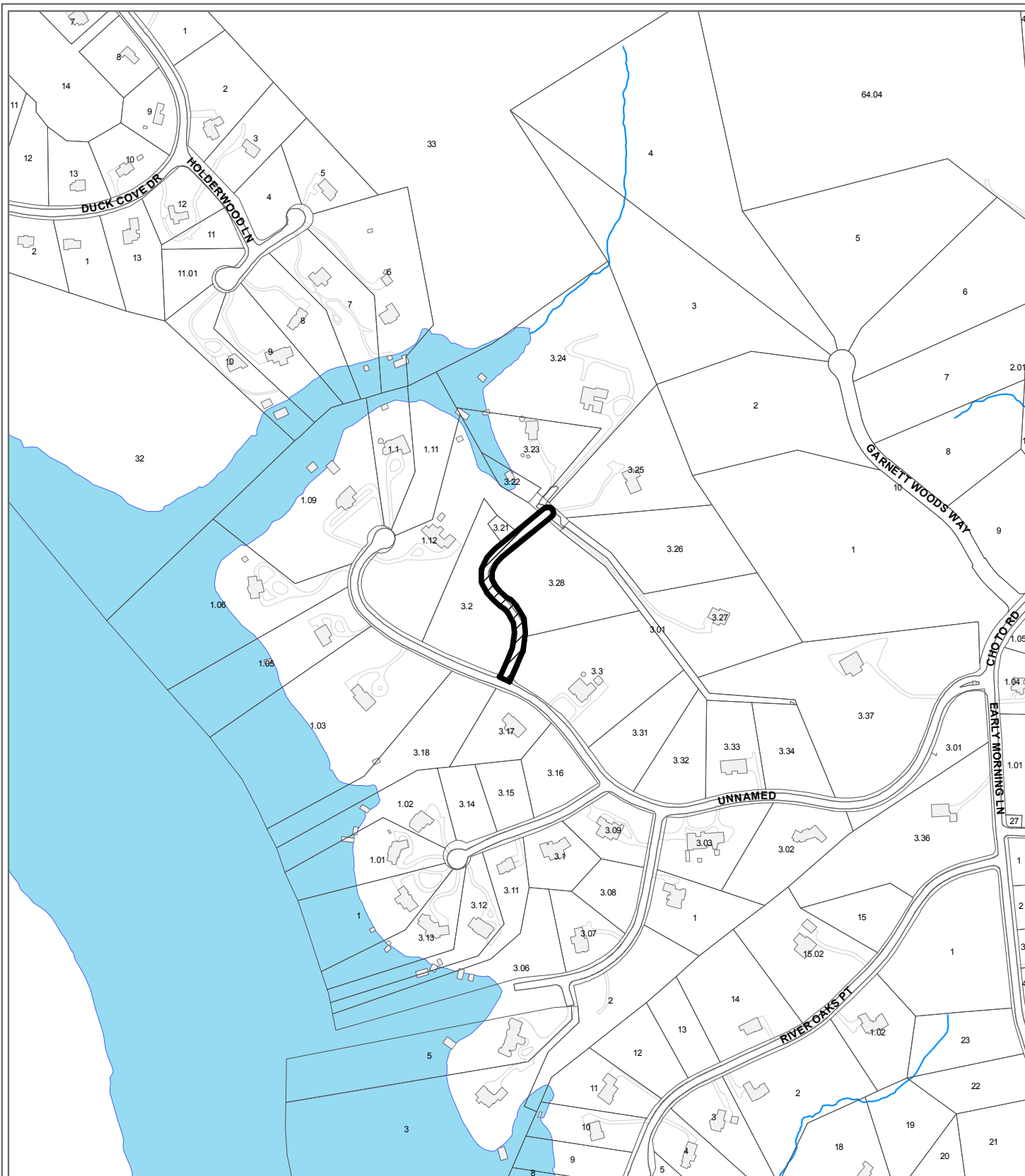
▶ **APPLICANT'S REASON FOR CHANGE:** Conform with the Knox County Street Naming and Addressing Ordinance
