STAFF RECOMMENDATION:


RECOMMEND that City Council APPROVE the closure, subject to any required easements.

Staff has received no objections to this street closure. The closure of this section of Evans St. will not adversely impact public access to property in the area, or access through the community.

COMMENTS:

The City of Knoxville Engineering Department had previously opposed this request, because there were concerns of leaving parcel 3 landlocked. This proposal had been tabled since March 13, 2008. Since then, the applicant has worked with Engineering to address their concerns. Engineering has now submitted an updated letter, dated November 16, 2009, stating no objection to the request (attached). Therefore, staff also recommends approval of the request.

If approved, this item will be forwarded to Knoxville City Council for action on 1/12/2010 and 1/26/2010. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.

SUBJECT: Request to Close a Portion of Evans Street MPC File # 3-A-08-SC / City Block 19160

Dear Mr. Brusseau:

This request was filed in February of 2008 by Knoxville Habitat for Humanity, Inc., to close that portion of Evans Street that lies southeast of Bonny Avenue. Closing this right-of-way at that time would have landlocked CLT Parcel #081-P-C-003, which was owned by an absentee owner. For that reason the Engineering Department could not support this request (see my letter of February 29, 2008 to Ken Pruitt), and it was tabled. This request has now been untabled and will be heard at the December 10 MPC meeting.

Habitat for Humanity recently acquired CLT Parcel #081-P-C-003, the parcel mentioned above. They already owned Parcels 081-P-C-002 and 004.

Parcel 081-P-C-002 fronts along the southeast side of Bonny Avenue and the southwest side of Evans Street. Parcel 004 fronts along the southeast side of Bonny Avenue and the northeast side of Evans Street. Therefore, once this portion of Evans Street is closed, all of it can be conveyed to Habitat.

I am told that Habitat plans to consolidate closed Evans Street with the three parcels and re-subdivide the total so that no property will be landlocked. Therefore, the Engineering Department does not object to this request.
