### **STAFF RECOMMENDATION:**

# APPROVE the closure of the street rights-of-way northwest of Langford Ave., within city blocks 26032, 26041 and 26042

These rights-of-way are paper streets that have never been improved or used for public access to this area. Under the South Waterfront Redevelopment Plan for this area, a reconfiguration of the land ownership patterns and public right-of-way access that will occur make these closures necessary.

### COMMENTS:

Future public access will be reestablished in this area through redevelopment consistent with the adopted South Waterfront Redevelopment Plan.

If approved, this item will be forwarded to Knoxville City Council for action on 4/7/2009 and 4/21/2009. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.

Dear Mr. Pruitt:

Closing this portion of Claude Street will land-lock Lots 28, 29, 30, and 31 of Section 1 of the Charles Jones South Knoxville Addition. Also, closing this portion of the Unnamed Street will land-lock Lots 50, 51, 52, and 53 of the Northern Division of the Jones Heirs Addition. Therefore, the Engineering Department requests that this closure be approved only if subject to the following conditions:

- 1 The property owner shall prepare and record a subdivision plat that combines these lots with other property so that none is land-locked.
- 2. The ordinance closing these rights-of-way shall stipulate that these closures shall not become effective unless and until the above plat is recorded with the Knox County Register of Deeds, and that if not recorded within one year of the date City Council gives its final approval, then these closures shall be null and void
