▶ **APPLICANT'S REASON FOR CHANGE:** South waterfront redevelopment project. Needed for final plat street names. **Note: No properties use either street name for addressing purposes. Final names selected will be recommended by City Public Properties and Facilities Naming Committee.**

STAFF RECOMMENDATION:

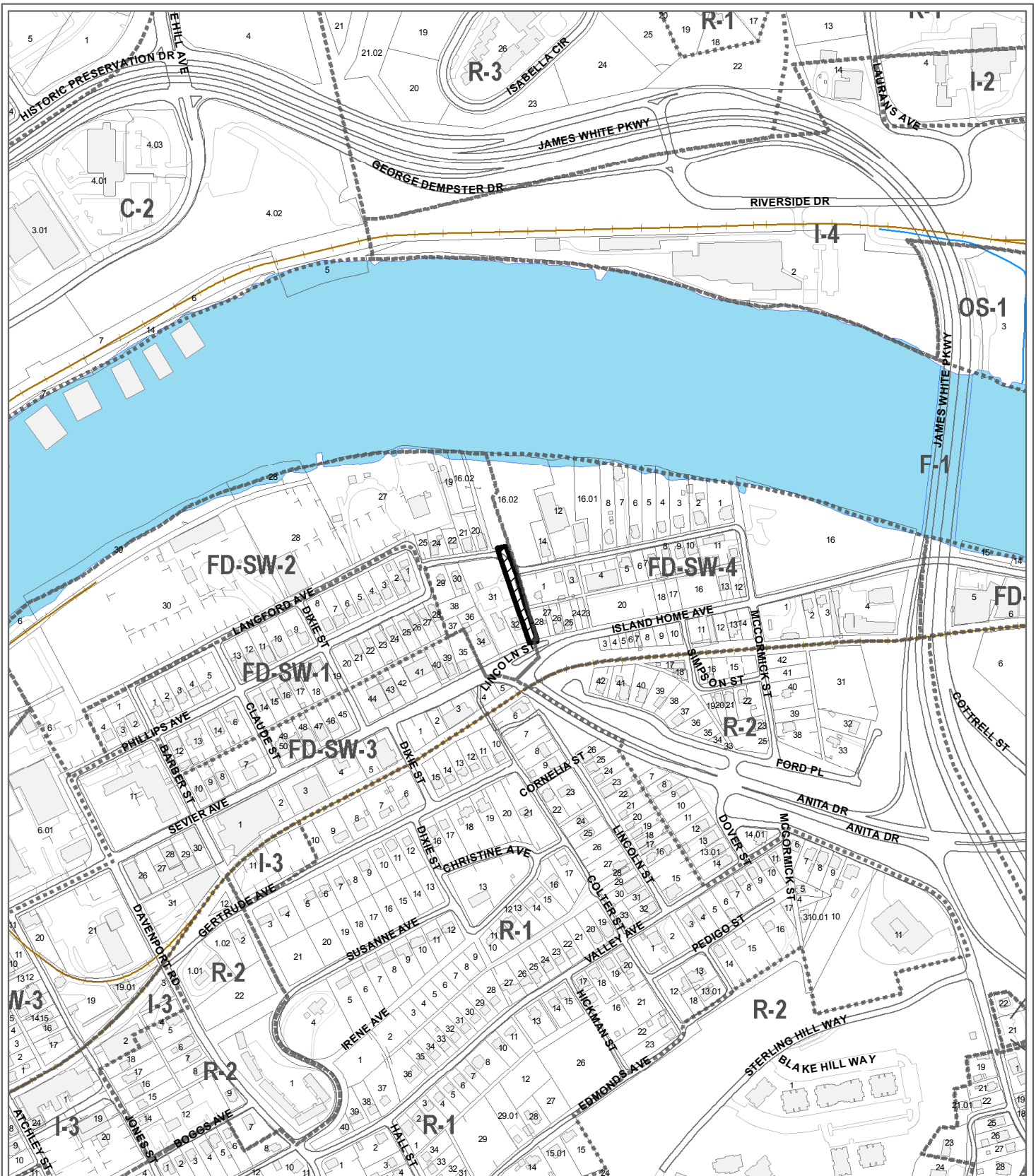
▶ **POSTPONE to the November 12, 2009 MPC meeting.**

Postponement will give the applicant more time to collect signatures from adjacent property owners, as well as determine which of the two proposed names will be the final street name, either 'Foggy Bottom St.' or 'Foggy Bend St.'

COMMENTS:

Owners of property adjacent to the subject street must be made aware of the proposed name change. The applicant is required to submit a 'Street Name Change Canvass Form' along with the application. This form is to be distributed to all adjacent property owners for their signatures, insuring that they are aware of the proposal. As of the date of this report, these signatures have not been received by MPC staff, so postponement is recommended until the signatures are obtained. MPC addressing reports that the proposed street names are available for use, but have not been reserved.

If approved, this item will be forwarded to Knoxville City Council for action on 11/3/2009 and 11/17/2009. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.
