
Staff has received no objections to this closure. The closure of this unnamed alley will not adversely impact public access to property in the area.

COMMENTS:

The City of Knoxville proposes to consolidate all the individual parcels for redevelopment of the site. The closure of this and several other rights-of-way in this area are necessary in order to consolidate all the property. In this area, there are four other right-of-way closure proposals by the City also on this agenda.

If approved, this item will be forwarded to Knoxville City Council for action on 3/9/2010 and 3/23/2010. If denied, MPC's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal an MPC decision in the City.

Dear Mr Brusseau:

This alley is located in the J.C. Sterchi Addition, Block 7 (Map Book 4, Page 102). It runs northeasterly from Century Street to the south right-of-way of Western Avenue. It is bounded on the west by Lots 12 through 20 and a portion of Lot 21 and on the east by Lots 1 through 11 of said Addition. This alley currently provides the only access to Lots 12 through 21. If it were to be closed, those lots would become totally landlocked.

For this reason the Engineering Department can support this request only with the following conditions:

- 1 The owner of the above Lots 12 through 21 shall prepare and record a new subdivision plat that results in no landlocked property.
- 2. The closing ordinance shall state that the closure shall not become effective until the above plat has been approved by the Metropolitan Planning Commission and recorded with the Knox County Register of Deeds, and the Engineering Department has sent a memo to the City Recorder verifying that all these conditions have been met.
- 3. The closing ordinance shall also state that if the plat is not recorded within one year from the date City Council gives its final approval, this right-of-way closure shall be deemed to be null and void and of no effect.
