SUBJECT: Agenda Item #50 - Request approval to purchase computers under

Knox County Agreement # B27160 with Dell Marketing, L.P.

This is to request approval to purchase 19 replacement personal computers and laptops and one new laptop from Dell Marketing, L.P. The total purchase is about \$29,700.00, or an estimated unit price of \$1,500.00. Five of the computers will be used by TPO staff and are eligible to be reimbursed 80 percent through our FHWA grant with TDOT for \$6,000.00. The remaining 15 computers are for MPC staff, general use, and the development service counter. The following budget line items have sufficient remaining funds to cover the purchase in fiscal year 2013-2014.

9500110-543500 MPC Small equipment and supplies \$23,700.00 pending purchase 9500210-543500 FHWA Small equipment and supplies \$6,000.00 pending purchase

MPC Policies and Procedures require purchases over \$10,000.00 be approved by the full Planning Commission if not budgeted in a separate line item. The computers were budgeted in a group line item including office supplies, software and small equipment.

Staff Recommendation: Staff recommends approval of the purchase.

MPC Executive Committee Review: The Executive Committee will review this request on Tuesday, March 11, 2014 at the MPC Agenda Review meeting and then be placed in Other Business for consent vote at the March 13, 2014 MPC Planning Commission meeting.
