The proposed street name is not a duplication and meets all requirements of the Knox County Street Naming and Addressing Ordinance.


### COMMENTS:

Staff has received no objections to the renaming of this right-of-way, and it meets all requirements of the "Addressing Guidelines and Procedures" section of MPC's Administrative Rules and Procedures. The application was necessary in order to assign an address to the property owned by the applicant (Parcel 021FA003). There are no addresses available on E. Emory Rd., so a new street name is necessary in order to assign an address.

If approved, this item will be forwarded to Knox County Commission for action on 3/27/2017. If denied, MPC's action is final, unless the action to deny is appealed to Knox County Commission. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 30 days to appeal an MPC decision in the County.






