Hello Michael,

I am not sure about other facilities, but with regard to the Riverdale School, it would appear that if we received a complaint, we would be required to rezone or come into compliance with this amendment. We could not come into compliance because we have 4.5 acres and the minimum is 10 acres (up from 5 acres in the original version) and you say the MPC would not support spot zoning or plan amendment. I urge that the minimum acreage be decreased.

In the alternative, if this is truly about new facilities, I urge that the following be added:

1. Properties on the Register of Historic places be exempted;
2. Properties that have historically operated without complaint be granted rural retreat status;
3. Existing properties that do not qualify can apply to be granted rural retreat status on a case by case basis.

Otherwise, I suggest that section L be amended to conform to IDA guidelines:

Outdoor Lighting Basics

Modern society requires outdoor lighting for a variety of needs, including safety and commerce. International Dark Sky Association (IDA) recognizes this but advocates that any required lighting be used wisely. To minimize the harmful effects of light pollution, lighting should

- Only be on when needed
- Only light the area that needs it
- Be no brighter than necessary
- Minimize blue light emissions
- Be fully shielded (pointing downward)
