Dear MPC Commissioners,

I will be at the meeting on Thursday, August 9th to request a postponement of the items related to the Legends at Washington Pike. A large amount of information about this project has dropped in the past three days, and the applicant has not taken had an opportunity to meet with all of the neighborhood groups to discuss the issued traffic study and plans.

The Alice Bell / Spring Hill Neighborhood Association has offered their meeting at 7PM on Monday, August 20th at New Harvest Park for a forum for the developer to meet with interested neighbors and community members.

In particular, the driveway access to McCampbell Drive is problematic, and the neighbors would like to ensure that adequate steps are taken with design and enforcement of limited access. A prior development nearby - Arlington Church and the Pointe at Lifespring, requested access on McCampbell Drive. Actions taken by MPC during [approval of 12-C-10-UR](#) on Dec 9, 2010 stated the following condition: "3. The driveway connection out to McCampbell Dr. is allowed for Phase 1 of the Church and the assisted living facility without any required widening of McCampbell Dr. subject to: a) the driveway being gated with the gate being closed with access controlled by a card reader or similar device; and b) the gate being allowed to remain open for a maximum period of four hours for Sunday morning services. The roadway for McCampbell Dr. shall be widened to 20 feet from the entrance east to Washington Pike prior to the completion of the improvements for the Phase 2 Church expansion. The widening of McCampbell Dr. shall meet the requirements of the Knox County Department of Engineering and Public Works. "

I just drove through the open gate access on McCambell Drive, and neighbors report this gate is routinely left open. McCambell Drive has not been widened between the passage of 12-C-10-UR and present day.
