SUBJECT: Agenda Item 7-A-18-OB - Similar Use Determination for Adult Day Care in the O-1, O-2,

and 0-3 District

Background

Damon Falconnier submitted an application on May 29, 2018 for a Similar Use Determination for a proposed adult day facility to be located at 4036 Gap Road. The property is currently zoned 0-3. The applicant has requested a rezoning to 0-1.

Discussion/Analysis

The zoning code is written in such a way that only those uses listed are allowed to be located within specific zones. A Similar Use Determination allows the Planning Commission to determine whether or not a proposed use is similar to, or not more detrimental than, a use that is already permitted.

The City of Knoxville zoning ordinance does not contain a definition for nor does it currently categorize adult day cares.

Evaluation

Both the 0-1 and 0-3 districts allow assisted living facilities and public and private schools as a use on review. The 0-1 district allows private day nurseries and kindergartens as a use on review.

Upon review of the proposed use, staff has found that adult day care centers serve a population similar to senior living facilities and are similar in use to private day nurseries and kindergartens.

The update to the City's Zoning Ordinance will include an updated definition for day care facilities that includes both adults and children.

STAFF RECOMMENDATION

Approve adult day care services as a use permitted on review in the 0-1, 0-2, and 0-3 districts as provided for by the similar use determination process.




