
We wish to make the Commission aware of serious problems of the proposed Laurel Falls Extension and request it be denied at the May 10 meeting.

The proposed Laurel Falls extension road is almost identical to a proposal submitted and later withdrawn in 2011. It will ruin our existing cul-de-sac. As in 2011, this appears to be Phase 1 of plans to construct a new subdivision above Cascade Falls Subdivision.

The developer Terry Patton claims he will just put in a "wide driveway" or a "common driveway", not a public road. This is obviously contradicted by the proposal before you.

This Phase 1 proposal alone would make no economic sense for Terry. Its cost would be far in excess of whatever value a second access road would add to the three unsold lots. But a Phase 2 will open the door to highly profitable development of a new subdivision above Cascade Falls. It could logically connect at Westop Trail to the neighborhoods above.

In 2011 Terry assured us he would not extend Laurel Falls beyond Phase 1. But this was contradicted by the concept plan filed in 2011:



Phase 1 work will be unusually expensive as it will cross a deep ravine that was used to dump huge amounts of excess dirt from construction of Cascade Villas Subdivision. Until late 2017, trucks just dumped dirt for a bobcat to spread. A small bulldozer was briefly used on a few occasions to spread large piles. I estimate this fill is at least 10 feet deep. The sides are not landscaped or terraced in any way, but just loose dirt that slid down as the bobcat pushed dirt close to the edge.

Thanks for your email, I just spoke with our Development Services folks and they advised the intent of the developer currently is to extend Laurel Falls Lane, making the extension a public roadway. Therefore, by doing so they will be required to submit a design plan to our Department and the work will be inspected/bonded to ensure all construction complies with Knox County standards, including compaction in deep fills.

The following pictures show the area of deep fill that will impact the cost of the Phase 1 plan before the MPC, making this plan highly financially undesirable if no further development is planned.





The effect on Cascade Falls Subdivision and especially on Cascade Falls Lane from Ball Camp Pike through Laurel Falls Lane would be devastating. Our quiet cul-de-sac will be ruined. Our quiet subdivision would become a major road with heavy construction traffic from the new subdivision, and a very attractive high traffic short cut between neighborhoods above Cascade Falls Subdivision to Ball Camp/Shaad Road. We respectfully request the MPC to consider these harmful impacts on our peaceful neighborhood.

A petition asking the MPC to deny extension of Laurel Falls Lane is being signed and will be presented to the MPC in the May 10 meeting.




