Subject: Major Road Plan 2018 Update

Staff Recommendation:

Approve the 2018 Major Road Plan update.

Comments:

The Major Road Plan is used as a tool in the coordination and regulation of land use to ensure that as development occurs the public's investment in the roadway infrastructure is protected by preserving roadway facilities for their intended purpose. Authority has been granted to the Planning Commission through Tennessee Code Annotated (TCA) for the adoption of the Major Road Plan. The Knoxville-Knox County Subdivision Regulations ensure conformance of land subdivision and street design with adopted transportation plans and programs. The subdivision regulations state that "right-of-way widths for classified streets shall be provided in accordance with the requirements of the Major Road Plan. The minimum right-of-way widths for classified streets (both existing and proposed) are required by the Major Road Plan to accommodate future road, utility, sidewalk and bikeway improvements."

The Major Road Plan is updated periodically to account for changes to the road network such as new roadways that have been built, and to reflect current transportation plans and their identified projects. The previous Major Road Plan was adopted in 2011 and it served as the starting point for this update with the majority of roadway classifications and associated right-of-way dedication amounts being carried forward.

As part of the update for the Major Road Plan, staff consulted with City and County engineering to determine what changes were needed. All changes with the Major Road Plan are scheduled to be presented at the September Agenda Review meeting on Tuesday. September 11, 2018.

The major changes that were made to the roadway classifications with this update are summarized in Appendix D of the Major Road Plan document (see attached table with changes in red). The changes generally fall into one of the six categories below:

1. Added roadways to the "classified" roadway list. All public roadways in Knox County are given a classification of either Local, Collector, Arterial, Expressway or Interstate. Only the roadways classified as Collector or higher are individually

identified in the Major Road Plan with their designation and right-of-way dedication requirement and therefore any other roadway that is not called out is considered to have a Local designation. The roadways that were added to the Major Road Plan tables may have resulted either from a previously undesignated (Local) road or because the road was recently constructed or planned for construction.

- 2. Corrected minor inconsistencies or nomenclature. Some roadways in the 2011 Major Road Plan were incorrectly identified as "Road" versus "Drive" or misspelled so these errors were corrected as necessary.
- 3. Updated termini. There were several roadways where modifications were made to consolidate separate sections or clarify the terminus point of a roadway classification.
- 4. Changed classification of roadways. The following roads had classification updates:

6. Removed or downgraded roadways. The following roads were removed from the Major Road Plan tables as either being determined to not warrant classification above Local or were previously planned road projects that are no longer proposed for implementation:

James White Parkway Extension
Jenkins Road
Murphy Road Extension
Old Tazewell Pike

Other notable changes with this update of the Major Road Plan include:

- 1. Additional detail provided in the text of the document on the purpose of the Major Road Plan and how it is used.
- 2. An appendix is provided with a listing of all major road projects in Knox County that have either been implemented within the last ten years, are funded and under development currently, or have been identified as future needs in the Knoxville Regional Transportation Planning Organization's 2040 Mobility Plan.
- 3. Typical cross section graphics have been provided in an appendix to generally depict the roadway elements that comprise the necessary right-of-way amount that has been established for each classification of roadway.
- 4. The roadway classifications and associated right-of-way dedication amounts have been incorporated into a GIS layer within MPC Cases on KGIS to greatly improve the ease of determining this information. In previous versions of the Major Road Plan this information was only available in a tabular format where one had to find a particular roadway and determine the appropriate location based on the listed termini. This has previously led to cases of confusion especially where roadways intersect others with the same name in multiple locations, e.g. Ball Camp Pike at Western Avenue.

KNOXVILLE-KNOX COUNTY METROPOLITAN PLANNING COMMISSION A RESOLUTION ADOPTING THE 2018 MAJOR ROAD PLAN

WHEREAS, the Knoxville-Knox County Metropolitan Planning Commission, a regional planning commission established pursuant to state statute, has the duty to make and adopt plans for the physical development within the City of Knoxville and Knox County;

WHEREAS, in its charter, the City of Knoxville has identified the Metropolitan Planning Commission as the planning agency responsible for the preparation of comprehensive development plans;

WHEREAS, the last Major Road Plan was adopted in 2011 and development patterns and the street and highway system continue to change;

WHEREAS, the City of Knoxville and Knox County adopted the Knoxville-Knox County General Plan 2033, providing an updated agenda for quality growth that should be reflected in the Major Road Plan;

WHEREAS, the Major Road Plan is identified in the Knoxville-Knox County Subdivision Regulations and is used in the process of regulating land use;

WHEREAS, the Metropolitan Planning Commission staff prepared the Major Road Plan update in consultation with city and county engineering departments;

NOW, THEREFORE, BE IT RESOLVED BY THE KNOXVILLE-KNOX COUNTY METROPOLITAN PLANNING COMMISSION:

SECTION 1: The Commission hereby adopts the Major Road Plan which identifies the roadway classification and required right-of-way dedication of the City of Knoxville and Knox County street and highway system. The Major Road Plan consists of text defining roadway classifications; tables identifying classified roads, the extent of and type of classification, and required right-of-way dedication; typical roadway cross-sections; planned roadway projects; a summary of changes; and a map that shows the functional classification of the street and highway system.

SECTION 2: The Metropolitan Planning Commission forwards this Major Road Plan to the Knoxville City Council and Knox County Commission for approval.

SECTION 3: Upon adoption of the Major Road Plan by the Metropolitan Planning Commission, Knoxville City Council and Knox County Commission, the Knoxville-Knox County General Plan 2033 is amended to reflect the updated Major Road Plan.
