Our backyard backs up directly to the above referenced property. We were shocked when we received the notification for the rezoning of this property. For 15 years we had vacationed in the Knoxville area and three plus years ago we decided to retire and finally put roots down in an area and state that had become home to us.

When we were looking for property we wanted an area that was still rural yet close enough to the downtown area. We found that in Wisteria Plantation. When we spoke with the builder regarding the lot we chose in the complex and the land behind it, we were told that it could not be built on as it was a floodplain and it was one of the reasons he had not purchased it when it had been on the market previously.

Strawberry Plains is already heavily traveled with commercial vehicles and cars. Also with the building of the truck depot that was recently passed across the street, this traffic will only continue to increase. Any type of development on this property will just add to this noise and congestion.

We endured almost three years of construction as the remaining condos were built next to our lot and across from it. We have finally been able to relax out on our screened patio and enjoy the peace and quiet we paid for.

We are petitioning that the rezoning be denied as it will disrupt the rural area setting, wildlife and the peacefulness of our community.
