Most of us have lived on Forrester for many years. My husband has owned his property there since the 1990's. The majority of us are home owners, not renters. This of course is another concern that I have about this proposed project. We are a quiet road and having renters moving in and out may disrupt our neighborhood as they tend to not care about the area as much as those who own the property. I am also concerned for the wildlife habitats that will be affected by the clearing of the land on these plots and the increase in cars which could hit and kill them. There are rabbit warrens, o'possum and raccoon dens and even a flock of turkeys that make this road their home as well. I would hate to see them disappear.
