(present street name) 'Summer Bird Dr.' TO: (proposed street name) Between Laurel Hill Road and Sanders Road LOCATION: SECTOR PLAN: Northwest County **GROWTH POLICY PLAN:** Planned Growth Area ZONING: N/A APPLICANT'S REASON FOR CHANGE: Due to the "double-crossing" of Venice Road with Sanders Road, on behalf of the Belmont West Association, we are requesting that the portion of Venice Road connecting Sanders Road and Laurel Hill Road be renamed.

STAFF RECOMMENDATION:

Approve the name change of the portion of Venice Road between Sanders Road and Laurel Hill Road to Summer Bird Drive to eliminate confusion stemming from recurring intersections of Venice Road and Sanders Road.

COMMENTS:

1. Venice Road makes a loop and connects with Sanders Drive at two points located approximately 988 feet apart. The applicant has proposed changing the street name of the portion of Venice Road that lies east of the northern intersection of these roads to eliminate confusion due to the intersection of the same roads occurring so close together.

2. The applicant has proposed changing the name of this portion of Venice Road to Summer Bird Drive.

3. Addressing staff has approved the proposed street name and all owners abutting the portion of Venice Road to be renamed have signed the petition in favor of the change.

4. There are no properties using this portion of Venice Road for access, so no address changes would be required if the street name change is approved.

5. Staff has received no objections to the renaming of this right-of-way.

6. The proposed name meets all requirements of the Addressing Guidelines and Procedures.

If approved, this item will be forwarded to Knox County Commission for action on 1/24/2022. If denied, Knoxville-Knox County Planning Commission's action is final, unless the action to deny is appealed to Knox County Commission. The date of the appeal hearing will depend on when the appeal application is filed.





Request to rename a portion of Venice Road

Background

Venice Road, shown on the map below, crosses Sanders Road at two intersections. (In the map below, the south direction is at the bottom of the figure and the north direction is at the top.) When someone is traveling from south to north and turns right at the first intersection, they enter Gulfpark subdivision. If they turn right at the second intersection, they will enter Belmont West subdivision.



There is no connection between Belmont West and Gulfpark subdivisions except for Sanders and Cedar Bluff roads. For many decades, the existence of two intersections, each between streets having the same names, has led to confusion. Drivers approaching from the south and seeking Belmont West mistakenly turn right at the south intersection and find themselves in "unfamiliar" territory in Gulfpark. A corresponding confusion occurs for drivers seeking Gulfpark and entering from the north. They turn left at the north intersection and find themselves in Belmont West.

Proposed Solution

1

The Knox County Code of Ordinances¹, Chapter 54, Section 54-37, Part B states,

(b) Extensions of existing streets, including extensions across intersecting streets, shall use the same name as the existing street; provided, however, that local streets which cross major connector or arterial streets may change names if approved after formal consideration by the Knoxville/Knox County metropolitan planning commission. (emphasis added)

Due to the "double crossing" of Venice Road with Sanders Road, on behalf of the Belmont West Association, I am requesting that the portion of Venice Road connecting Sanders Road and Laurel Hill Road be renamed (list of possible names given below). The new road is highlighted with a yellow line in the photo below.

Changing the name of this small section so that it is a separate street would alert drivers that "this is the entrance to Belmont West, Gulfpark is the other one."

Note that Section 54-34 specifies the following,

(1) All public streets generally extending easterly and westerly shall be designated drives or avenues.

Note that no residences have property addresses on this portion of Venice Road. The four houses visible in the above photo have been confirmed by Knox County Property Search to have identified addresses on either Sanders Road or Laurel Hill Road. The remainder of Venice Road would remain as is.

Request

Suggested Names

The Belmont Stakes is a well-known horse race run at Belmont Park in Elmont, New York. The streets in Belmont West Subdivision are named for horses that have won the Belmont States race or are named for streets or properties associated with Belmont Park. Keeping with this tradition, the following names are proposed:

Summer Bird Drive Damascus Drive Counterpoint Drive Saxon Drive Cloverbrook Drive Sarava Drive
