•	APPLICANT'S REASON FOR CLOSURE:	The closure is a necessary part of the development plan for the construction of the multi-use stadium.
	DEPARTMENT-UTILITY REPORTS:	KUB has utilities in the area and has requested to retain all easements and rights for existing utilities.

STAFF RECOMMENDATION:

Approve closure of the portion of Campbell Avenue between S. Hall of Fame Drive and Patton Street since it is needed for the multi-use stadium/mixed use planned development, subject to two conditions.

1. Project must obtain plan development approval, City Council and County Commission funding approval, and sufficient design must be completed to meet transportation needs subject to City Engineering approval before the closure can become effective. If the project does not meet the requirements, the closure shall become null and void and of no effect.

2. The City will reserve easements for all drainage facilities and utilities, if there are any current facilities, located in or within five (5) feet of the property described herein. No easements are reserved if there are no current facilities within the closure area. If any existing facilities or utilities are found not feasible to the site development or use, they may be removed and relocated, subject to City Engineering and/or other applicable easement holder review and approval.

COMMENTS:

1. This request is to close Campbell Avenue between S. Hall of Fame Drive and Patton Street. This section of Campbell Avenue does not provide access to any properties, nor does it connect any streets. The portion of Campbell Avenue between Patton Street and Florida Street was closed in 1991 (Ordinance O-35-91), making this portion of Campbell Avenue a remnant. Though it retains the Campbell Avenue name, it has been classified as an alley.

2. The multi-use stadium/mixed use planned development is proposed for the property surrounding this portion

of Campbell Avenue to the east and will include a large area affecting multiple blocks. The area comprising this right-of-way is needed as part of that project.


3. No address changes would be necessitated with this closure.

4. Staff has received no objections from the general public.

5. In addition to comments from City Engineering (approval conditions 1 and 2), the following departments and organizations had these comments:

- a. KUB: We have reviewed our records and find that we have existing utility facilities located within the subject right-of-way. The approximate locations of these facilities are indicated on the enclosed prints. However, KUB does not release and hereby retains all easements and rights for existing utility facilities, whether or not shown on these prints. Should this right-of-way be closed, KUB will require the following permanent easements for its utility facilities.
 - Water 7.5 feet on each side of the centerline of the water line, 15 feet total width
- b. TDOT had no comments.
- c. AT&T had no comments.
- d. The Fire Department had no comments.

If approved, this item will be forwarded to Knoxville City Council for action on 12/14/2021 and 1/11/2022. If denied, Knoxville-Knox County Planning Commission's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal a Planning Commission decision in the City.






