Subject:	Fiscal Year 2023-2024 Budget 6-B-23-OB

Knoxville-Knox County Planning's proposed budget for Fiscal Year 2023-2024 is provided for your review and approval. The Executive Committee recommends approval of this budget.

Planning staff has developed a balanced budget, with revenues and expenditures each identified at \$7,744,031. Appropriations from the City of Knoxville and Knox County are an important source of revenue for the agency and represent 37 percent of the projected total. The City of Knoxville's allocation will remain at last year's level of \$1,304,900, Knox County's allocation will remain the same as last year at \$843,413. This overall budget growth is due to increased transportation grant funding to support special planning studies including continued pavement management assessment for local governments, consultants to begin the update of the regional long range transportation plan and a special transit study. We will also receive funding from an EPA grant through the City of Knoxville.

Highlights of the budget include:

- The City of Knoxville's appropriation is 17% of total revenues and Knox County's is 11%.
- Fee revenue will account for approximately 8% of total projected revenue.
- Grant reimbursements will account for approximately 60% of agency revenue.
- Of the approximately \$4,664,322 of grant revenue, \$3,832,001 is pass through to agencies that provide transportation services to the elderly and disabled or consultants.
- The budget includes a 3% cost of living raise for all employees.
