
STAFF RECOMMENDATION:

Approve the name change from Andes Road to Ball Road as requested by Knox County Engineering & Public Works.


COMMENTS:

- 1. The Knox County Department of Engineering and Public Works has requested to change the street name of Andes Road due to the realignment of Schaad Road.
- 2. Ball Road will extend from Ball Camp Pike to the new terminus created at Schaad Road. This proposal is to rename the section of Andes Road to Ball Road starting from the new terminus at Schaad Road to the northeast corner of parcel 091PA037 (see the blue segment encircled in purple in Exhibit B). This name change complies with the Knox County Uniform Street Naming and Addressing Ordinance, to ensure there are no non-contiguous streets.
- 3. Addressing staff coordinated with Knox County Engineering and Public Works to determine appropriate street names for these segments based on the logical extension to connecting streets.
- 4. The proposed street name change from Andes Road to Ball Road will require four addresses to be assigned.
- 5. Planning has received no objections to the renaming of the right-of-way.
- 6. The name change meets all requirements of Knox County's Code of Ordinances, Chapter 54, Article II, Section 54-40.

If approved, this item will be forwarded to Knox County Commission for action on 11/12/2024. If denied, Knoxville-Knox County Planning Commission's action is final, unless the action to deny is appealed to Knox County Commission. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 30 days to appeal a Planning Commission decision in the County.





Sign Posting & Removal Requirement

Revised April 2021

The Administrative Rules and Procedures of the Knoxville-Knox County Planning Commission require a sign to be posted on the property for each application subject to consideration by the Planning Commission, including the following applications: rezoning, plan amendment, concept plan, use on review/special use, planned development, right-ofway closure, and name change.



The required public notice sign(s) will be provided by Planning to the applicant when an application is submitted. If an application is submitted electronically, Planning staff will post the required sign. If a replacement sign(s) is needed, the applicant is responsible for picking up the new sign(s) from Planning and will be charged \$10 for each replacement.

LOCATION AND VISIBILITY

The sign must be posted on the nearest adjacent/frontage street and in a location clearly visible to vehicles traveling in either direction. If the property has more than one street frontage, the sign should be placed along the street that carries more traffic. Planning staff may recommend a preferred location for the sign to be posted at the time of application.

TIMING

The sign(s) must be posted **not less than 12 days prior to the scheduled Planning Commission public hearing** and must remain in place until the day after the meeting. In the case of a postponement, the sign can either remain in place or be removed and reposted not less than 12 days prior to the next Planning Commission meeting. The applicant is responsible for removing the sign after the application has been acted upon by the Planning Commission.
