Since he has learned to drive both Laurel Ridge and Windemere Trails have become more and more populated and using the turn lane on Hardin Valley is taking your life in your hands. It appears the roads, schools, drainage, and wildlife in the area cannot keep pace with the development.

When visiting the Knoxville-Knox County Planning website, searching on "Hardin Valley", and visiting on specific cases, I have yet to find any of the citizens that live in Hardin Valley support these various rezoning and land development requests. Over and over the citizens that live here cited traffic issues, over crowding of the schools, and environmental concerns. Kim Frazier and the Hardin Valley Planning Advocates have produced a report with specifics on the school overcrowding, traffic concerns, and more.

# **AMY MIDIS**




Her goal as a commissioner is to encourage a sustainable, healthy community where residents are able to age in place and enjoy close proximity to work and commerce.
